Questions for Marion County Utilities

- 1. How many acres will be developed in and around Oak Run by the Marion County Utilities for the Waste Management facility proposed expansion projects?
- 2. What is the location of property to be developed in and around Oak Run?
- 3. Is there written documentation, plans, engineering plans previously submitted or already used for the expansion project and future expansion proposals in and around Oak Run, documentation showing funding, projects plans, grants obtained and expansion funding?
- 4. What is the time-line for Oak Run expansion to start and be completed?
- 5. Has the county bought additional property adjacent to Oak Run for proposed Waste Water Management facility expansion in and around the excising facility and several Oak Run communities?
- 6. What is the proposed increase (projected Build out) (Capacity levels) to the existing facility's processing tanks/containment units and disposal units through the completion of the expansion project?
- 7. Are there additional sewage and reclaim infrastructure upgrades included in the expansion proposal and facility upgrade in and around Oak Run.
- 8. How many sludge tanks will be added to the existing facility throughout the projected completion of the expansion project?
- 9. What other areas in and around Oak Run are projected for additional sewage lines, lift stations and purge values through completion of the expansion project?
- 10. What has Marion County Utilities considered/implemented to protect Oak Run residents/community from negative effects of the daily operation this waste management facility creates?
- 11. How often does the removal of the sludge tanks occur on a weekly basis? How many sludge tanks are there currently?
- 12. What has Marion County Utilities planned to aesthetically conceal/blend into the community and surrounding environment to ensure no devaluation of Oak Run property values?
- 13. What is the cost of the proposed expansion past and future?
- 14. What plans to update aging infrastructures, i.e., sewage lines, lift stations purge valves, i.e. all components are proposed in the expansion proposal?
- 15. What plans does Marion County Utilities have to eliminate odors imitating in and around the waste water treatment plant and from the vast miles of sewage components throughout Oak Run communities, and when will they be implemented?
- 16. What plans does Marion County Utilities have to eliminate noise imitating in and around the waste water treatment plant effecting quality of life to Oak Run communities, and when?
- 17. Is Oak Run selected as one of the Waste Management sites that will be expanded to accommodate other facilities being decommissioned within Marion County?

- 18. What is the load capacity of this facility in terms of population and what level are we currently?
- 19. Is this facility rated as an A-B-C type facility?
- 20. What expansion planned are projected for development of this facility?
- 21. How many communities/business are projected to be added to this facility?
- 22. What engineering upgrades or expansions have been developed to address the aging facility and infrastructures and to address the ongoing issues?
- 23. Where are the entry connections for outside communities/business located that connect to the main intake flow to this facility
- 24. Why is there not a technician on duty 24/7?
- 25. How many pump/lift stations in Oak Run and adjacent areas are there?
- 26. Is the Waste Water Facility and Pumps/Lift stations remotely monitored using SCADA (Supervisory Control Data Acquisition) system by Utility Company technician 24/7?
- 27. How often are the pump/lift station professional cleaned/vacuumed, debris removed, jetted then chemically treated?
- 28. How many purge valves are there within Oak Run and where are their locations?
